IV. Executive Director's Report

Fiscal

The Illinois Liquor Control Commission totaled \$448,696 in revenue for February, 76% of that total was from licensing and 24% was enforcement and includes fines, penalties, and violations.

We continue to see a decreases from the 1A (retail license) fee waiver and the license renewal extension.

Fines, Penalties, and violations are up for FY2022 due to new hires within our enforcement division.

ILCC staff are preparing for our General Assembly appropriations committee hearings. Our Senate hearing is scheduled for next week and the House hearing is the first week of April.

Human Resources

We are budgeted for a headcount of 64 employees and are currently operating with 70% of that authorized headcount.

The ILCC has submitted eight (8) job descriptions for approval by CMS. These are for our Liquor Control Inspector Trainee positions in:

Districts 6 (SW Cook), 11 (Eastern DuPage), 12 (Eastern Lake), 5 (Downtown – Spanish Speaking), 4 (West Central Cook), 15 (Ogle), 22 (Adams County), and 3 (Lakeview, Irving Park, Wrigleyville).

We have identified a candidate for the Chief of Enforcement and Chief of Internal Affairs and are extending offers to them.

Our agency has identified a top candidate for the paralegal position, and we will make a formal offer once approved by CMS.

The Chicago licensing assistant position is still under minimum qualification review with CMS.

Licensing

There currently are 31,156 active licenses throughout the state and 2,694 licenses were issued in February 2023.

97% of applications were submitted electronically and we had 114 in person transactions.

One of the Commission's goals for 2023 is to encourage more special event licenses to apply for their licenses via MyTax to help expedite the review and processing of requests.

Public Act 102-1142, which reduced license fees for Illinois wineries, was signed into law.

There were 816 retailers reported delinquent for the month of January and 866 were cured. These figures include roll overs from previous months.

Enforcement

The ILCC's enforcement division conducted 1,096 inspections, discovered 395 violations. 175 of these inspections were pre-licensing inspections.

We issued 111 warnings.

Enforcement reports that the most common violations found were: 1.) Personnel not being BASSET certified, 2.) Pregnancy warning signs not being properly displayed, 3.) State Liquor License not being properly displayed, 4.) Contaminated liquor being found, and 5.) Business not being in good standing with the Secretary of State.

Our Commission received 76 complaints in February and the most common complaints were: 1.) sale of alcohol to minors, 2.) operating without a valid license and 3.) retail-to-retail purchase of alcohol.

Enforcement continues to monitor the internet for illegal sales of alcohol. We removed 43 listings from Craig's List, 6 from Facebook Marketplace, and 20 from Offer-Up.

Legal

Legal has 65 cases pending before the Commission: 10 distributor cases, 4 sale of alcohol to minor case, and 51 retail cases.

61 cases were closed in the month of February and there are currently 35 Pre-Disciplinary Conferences outstanding, with 10 being conducted in February.

We have 17 appeals cases before the Commission, which do not include other open cases.

The ILCC received 18 FOIA requests.

Legislation

The Illinois General Assembly has 15 substantive liquor bills and 39 liquor shell bills introduced for spring session of the 103rd General Assembly. We continue to monitor and provide input on the bills.

Since the arrival of alcoholic soft drinks in retail stores last fall, the ILCC has introduced HB 2502 and SB 2433, which seeks to safeguard the Illinois public from deceptive product placement and marketing. If passed, the bill would require alcoholic soft-drinks to be shelved with alcohol and not with products that cater to minors, or other soft-drinks.

Industry Education

Industry Education has seen continued success with its BASSET program, thanks for the 160 plus BASSET providers, which are located across the State. BASSET trainings grew to 8,727 in February.

Our Social Media presences is steadily growing, and we continue to engage the public with educational content on our platforms.

We are participating in the Children of Addiction Awareness Week (February 12th through 18th), along with the National Association for Children of Addiction.

Our latest podcast on contaminated liquor is available on Spotify.

On March 8th, we conducted a licensing webinar that had over 100 attendees. The recording is available on our YouTube channel.
