III. Executive Director's Report

- **Audit**
 - This is the third audit as a stand-alone agency
 - We have received 330 audit requests.
 - 48 of which are electronic data processing.
 - Auditors hope to wrap up this portion of the audit by mid-December.
- **Fiscal**
 - \$9.2 Million in the Dram Shop Fund
 - The ILCC operating budget
- Our October 2025 Revenue - \$1.7 Million
 - Licensing division generated 95%.
 - Fines/Penalties and Violations generated approximately 5%.

- **Licensing**

- October 2025 Figures
 - Active licenses – 31,157
 - 2,465 issued.
 - 210 new applications
 - Special event licenses
 - 332 were this month
 - 90% was submitted online.
 - 4,339 were issued year to date

- **Salesforce**

- We are continuing to work with DoIt to transition from Gentax to Salesforce to handle the majority of ILCC's Licensing Enforcement, Legal, and Basset process.
- We are planning to release early 2026.
- December and January will be dedicated to user acceptance testing training and public outreach.

- **Delinquency list**

- 1,555 Delinquencies Reported
- 1,449 Cures.
- There were 9 Bona-Fide disputes filed for the month.

- Inspections Totals for February

- Total of 728 Inspections.
 - 5 were pre-licensing inspections
 - 83 were First Inspections.
 - 232 violations were cited.
 - Most common violations
 - Contaminated Liquor
 - Personnel not BASSET certified.
 - Liquor purchased at retail versus by a licensed distributor.
 - Corporate status not in good standing.
 - Pre-mix not destroyed weekly.
 - ILCC license not displayed.
 - IL Sales Tax certificate unavailable
 - 54 warnings were issued.
 - Most common
 - Pregnancy Warning Sign not displayed.
 - 90 days of invoices not being available.
 - ILCC license not being displayed.
 - Taps not being cleaned as required
 - Not having Tap Cleaning records.

- Complaints
 - The ILCC received 77 complaints in October. The complaints came via the online submission form, email, phone calls, and in-person information.
 - The most common complaints were operating without a valid license, the sale of alcohol to a minor, and happy hour violations.
 - Enforcement investigated and closed 15 complaints.
- Underage Compliance Details totals:
 - 14 Underage Compliance missions
 - 182 establishments were checked.
 - 30 failures
 - 152 were compliant.
 - 28 prior offenders were retested for compliance.
 - 4 repeat offender failing again.
- Online marketplace sales
 - Removed from marketplace:
 - 10 posts from Craigslist
 - 7 posts from Facebook Marketplace
 - 1 post from Offer-Up
- **Legal**
 - 196 cases pending
 - 2 distributor cases.
 - 97 retailer cases.
 - 97 sales of alcohol to minor
 - 86 first offense.
 - 8 second offense.
 - 3 third offense
 - Closed 190 cases.
 - Pre-disciplinary conferences
 - Conducted 7 pre-disciplinary conferences.
 - 9 outstanding
 - Appeals
 - 3 pending appeals
 - Last appeal status was held October 9, 2025.
 - Sale of Alcohol to Minors (SAM)
 - SAM settlement training conferences
 - November 19th, 2025, at the Chicago office
 - November 25th, 2025, at the Springfield office.
 - FOIA
 - Received 16 FOIA requests.
 - Administrative review
 - 3 are under administrative review.
 - Other legal pending matters:
 - 22 CV 4956-Freehan v. Berg, et al. (Full Pull Wines)
 - On September 25, 2025, Judge Jeremy Daniel of the United States District Court for the Northern District of Illinois (Eastern Division) issued a decision in favor of the Illinois Liquor Control Commission in support of the Illinois three-

tier alcoholic beverage regulatory system. Judge Daniel agreed with the Commission's argument that the Illinois Liquor Control Act may legally prohibit a retailer in another state from shipping alcoholic beverages directly to an Illinois consumer. Based on affidavit testimony of ILCC staff Kenneth Williams and Dusanka Marijan, Judge Daniel ruled that retailers selling alcoholic beverages in Illinois must be physically located and licensed in Illinois and must purchase alcoholic beverages from Illinois distributors before selling to Illinois consumers. Such a process preserves Illinois' three-tier regulatory structure and promotes the health and safety of Illinois residents.

- Commissioner Gibbons asked about the wine shipper licenses being down by 60% year to date.
- The commission and the director discussed the issues with shipping alcohol and delivery services (USPS UPS, FedEx) and the lack of education surrounding said topic.
- Commissioner Spann-Cooper asked about BASSETT training and ways we can upgrade this training.
