**II. Executive Director's Report**

The ILCC's move to the Daley Center is now complete. Commission meetings will be in person and all are welcomed to attend.

We have seen a 46% increase of new licenses issued since last year.

To meet the increase, the ILCC has hired two new licensing assistants that will start in November and we will be hiring a third for the Springfield Office.

As for Covid-19 related, liquor license renewal extensions, those will expire by December of this year.

With the v12 of Gentax being implemented, the ILCC has posted instructions on our website to help license holders navigate the system.

We will be putting out an R.F.I. to replace Gentax. Gentax is a revenue based system and is cumbersome for our ILCC needs.

HR is processing the applications for new agent applicants, so that they can move on to the next phase of the hiring process.

As for legal, we have 35 Sales of Alcohol to Minor cases pending in Springfield.

CMS is approving a Chief of Internal Affairs position for the ILCC.

Telework policy is currently being negotiated with AFSCME but has been implemented. Licensing staff is in the office full time, everyone else is on a 3-day hybrid schedule.

### **III. Division Reports**

Enforcement continues to continue its online monitoring of illegal sales.

On investigations, a Special Agent was contacted by municipal police about an illegal venue with B.Y.O.B. A felony warrant was issued to the owner of the club due to two shootings at the establishment.

Industry Education announced that the annual College-Town Summit for October 21<sup>st</sup>. Registration is online.

October 28<sup>th</sup> is the ILCC's first server training on Human Trafficking.

Legal provided an update on pending appeals and other cases. Lebamoff was dismissed by the plaintiffs voluntarily.

United States Supreme Court did not hear the Sarasota Wine Case against Missouri.

Legal continues to reduce its backlog of cases and we have increase the amount of appeals cases to be heard each month.

Licensing mentioned that we have had over 300 walk-ins and online renewals are still being utilized which is great to see.

Special Event licenses and new licenses tend to be our largest walk-ins. With special events, we are returning to pre-Covid levels for Special Events licenses. Organizers are still turning in applications last minute and the ILCC works hard to get them turned around right away, but we are continuing to work with municipalities to review and get them to us in a timely manner.
