**I. *Lantern House v. Forest Park (21 APP 09)***

Counsel Haymaker summarized the facts of the case and the arguments from each counsel representing the parties involved. Counsel Haymaker advised the Commission on the motions available to them in making a decision.

**II. *Forest Park Tap v. Forest Park (21 APP 12)***

**III. *Lacey's Place LLC***

Counsel Zisook informed the Commission of the facts surrounding a 3<sup>rd</sup> violation related to the Sale of Alcohol to Minors and advised the Commission of what motions they can make in deciding the case.

Commissioners agreed to a \$2500 fine and a two (2) day suspension of the license, and would hold the vote in open session.

**IV. Mala, LLC d/b/a Lindy Lu's Place**

Counsel Zisook went over the facts of the case surrounding a 3<sup>rd</sup> violation related to the sale of alcohol to a minor and advised the Commissioners on the motions available to them.

The Commissioners settled on a \$2,500 fine and two (2) day suspension of the license. A vote would be held in open session.

**V. Passero, LLC (22 CR 0015)**

General Counsel Quanbeck summarized the status of the delinquent tax cases with the Illinois Department of Revenue.

The Commission agreed to make a motion and vote in open session.

**VI. Shreeji Liquor, LLC (22 CR 0016)**

General Counsel summarized the status of the delinquent tax case with the Illinois Department of Revenue and recommended dismissal based on their being current after the fact.

The Commission agreed to make the motion and vote in open session.

**VII. El Plan de Lobos, LLC (22 CR 0017)**

Mr. Quanbeck presented the current status of the delinquent tax case with the Illinois Department of Revenue as being current and recommended dismissal based on the new set of facts.

The Commission agreed to make the motion and vote in open session.

**VIII. Eggs to U, LLC (22 CR 0018)**

General Counsel Quanbeck presented the facts of the delinquent tax cases with the Illinois Department of Revenue and advised they still we delinquent.

The Commission agreed to make a motion to revoke the license and take a subsequent vote in open session.

**IX. A motion was made by Commissioner Powell to move out of Executive Session and was seconded by Commissioner Gibbons.**

The vote was unanimous.
