Illinois Liquor Control Commission Underage Compliance June Report

SPRINGFIELD – In June 2026, the Illinois Liquor Control Commission (ILCC) conducted alcohol age compliance checks around the state and visited 122 businesses licensed to sell alcoholic beverages. 21 licensees were cited for selling alcoholic beverages to persons under the age of 21.

This is a monthly aggregated report of all the underage compliance investigations conducted in the month of June. The ILCC may release results on individual investigations through shorter press releases throughout the month.

The monthly aggregated report lists all the results of ongoing undercover and cooperative law enforcement operations conducted by Illinois Liquor Control Commission (ILCC) Special Agents and Investigators, law enforcement officials and volunteers from high schools and colleges. The teams randomly visit liquor stores, restaurants, and bars in communities around the state to check for ongoing compliance with state laws mandating that no liquor is sold to minors under the age of 21. ILCC Special Agents and Investigators also work with local and state law enforcement agents to focus on communities with a high incidence of underage liquor sales.

Below is a list of details conducted this month which include those establishments that violated the law by selling alcohol to ILCC underage participants. Because the visits are random in nature, certain areas of the State are visited at certain times of the year.

Madison County – June 4, the ILCC, in coordination with Illinois State Police, conducted underage compliance checks. Of the 21 licensees checked, 6 sold alcoholic beverages to persons under the age of 21. Those licensees were:

Cook County – June 11, the ILCC, in coordination with Chicago Police Department, conducted underage compliance checks. Of the 8 licensees checked, none sold alcoholic beverages to persons under the age of 21.

St. Clair County – June 11, the ILCC, in coordination with Illinois State Police, conducted underage compliance checks. Of the 21 licensees checked, 4 sold alcoholic beverages to persons under the age of 21. Those licensees were:

Kane County – June 25, the ILCC, in coordination with East Dundee Police Department, conducted underage compliance checks. Of the 14 licensees checked, none sold alcoholic beverages to persons under the age of 21.
