





Class 1 Brewer: No more than 930,000 gallons (all gallon maximums shall be reduced by the amount of beer produced for final packaging by commonly owned brewing entities).

Class 2 Brewer: No more than 3,720,000 gallons. (all gallon maximums shall be reduced by the amount of beer produced for final packaging by commonly owned brewing entities).
