<u>ORDER</u>

This cause coming to be heard before the Illinois Liquor Control Commission (the "Commission") on the motion of Appellee City of Harvey Liquor Control Commissioner Christopher J. Clark's ("City Liquor Commission") Section 2-619 Motion to Dismiss the appeal of Appellant SBX Management Corp. d/b/a Skybox Steak & Sports Bar's ("SBX"), SBX not having filed a written response to said motion or otherwise appeared to contest the motion at the September 10, 2021 hearing regarding same, the Commission having reviewed the motion, having jurisdiction hereover and being fully advised in the premises, does state the following:

SBX's appeal of the City Liquor Commission's March 25, 2020 order denying its 2019-2020 liquor license renewal application has been mooted by the City Liquor Commission's subsequent uncontested and unappealed order dated February 9, 2021, rejecting SBX's bid to renew its local liquor license for the 2020-2021 term. The latter order was properly served on SBX and SBX did not appeal said ruling within the time allowed by 235 ILCS 5/7-9. As a result, SBX has no current City of Harvey liquor license, nor any right to appeal. This has rendered SBX's 2019-2020 liquor license application moot.

IT IS HEREBY ORDERED:

The City Liquor Commission's Motion to Dismiss the appeal in the above-captioned matter is granted with prejudice. THIS IS A FINAL ORDER.
