The **Legal Division** is responsible for counseling the Commissioners and the Executive Director on interpretations of the Liquor Control Act and its Rules and Regulations. The Division also serves in a prosecutorial role reviewing and at times approving violations issued to licensees as a result of inspections conducted by the Enforcement Division. In its prosecutorial role, the Division may issue Offers in Compromise, conduct settlement conferences through the Pre-Disciplinary Conference process, or represent the ILCC before the Commission during an Administrative Hearing. Additionally, the Legal Division provides the public with assistance in interpreting and explaining Liquor Control Act and Administrative Rules.
